

~ A number of important activities took place in 2023 ~



[40th UN/CEFACT Forum](#) took place from 8 to 12 May 2023 in Geneva. This first-ever hybrid Forum with a record level of participation brought together 350 in-person participants from over 55 countries and welcomed an additional 1,500 virtual attendees. The five day-long gathering included 36 interactive sessions, providing a platform for global trade experts from the public and private sectors to explore standards and recommendations for trade facilitation while examining emerging trends in trade, transport, finance, and e-business, as well as resilience and sustainability.



The [2023 meeting of the UN/LOCODE Advisory Group](#) was held on 11-12 May 2023. Following the decision to set up a UN/LOCODE Task Force to address the UN/LOCODE maintenance policy issues, the UN/LOCODE Task Force was launched at its kick-off meeting on 28th September 2023.

As requested, at the 29th UN/CEFACT Plenary, the Group's Programme of Work (2024-2025) was approved and the mandate of the UN/LOCODE Advisory Group was extended with another two-year term.



The [41st UN/CEFACT Forum](#) took place from 2 to 5 October 2023 in Bangkok. Co-hosted with ESCAP, this Forum gathered over 300 trade facilitators from over 60 countries both in-person and online. The Forum's overarching theme focused on digital and green transformations as well as climate action for sustainable development, aligning with recent

decisions by member States at the Commission sessions of UNECE and ESCAP. Among key areas of focus was the adoption of digital technologies to enable streamlined and efficient supply chain processes.



The [29th UN/CEFACT Plenary](#) session held in November 2023 gathered nearly 60 participants from 22 UN Member States in the session to review and endorse the UN/CEFACT deliverables produced since the last Plenary. Those included the ECE Recommendation No.48 on Private Sector Participation in National Trade Facilitation Bodies, the latest versions of key UN/CEFACT standards, reports on activities of the UN/LOCODE Advisory Group and the Team of Specialists on ESG Traceability of SVC in the CE as well as updates from various UN/CEFACT domains.

In addition, this session marked the successful election of six UN/CEFACT Vice-Chairs nominated by Australia, Azerbaijan, Canada, France, Italy, and the Kyrgyz Republic for the term of 2023-2026 as well as three Regional Rapporteurs from Brazil, Japan and Senegal to promote UN/CEFACT activities in Latin America, Asia and the Pacific, and Africa during 2023-2025.



The [3rd Meeting of Team of Specialists \(ToS\) on Environmental, Social and Governance Traceability of Sustainable Value Chains](#) took place on the 23rd of November 2023. This multi-stakeholder, collaborative and cross-sectoral dialogue convened 50 experts from +20 countries in Geneva and 40 experts online, to forge international collaboration and synergies. Interoperability of information exchange is one of the key needs identified to scale up access to ESG data in value chains. The [draft UNECE Recommendation No. 49](#) on 'Transparency at Scale' will aim to scale traceability, transparency and trusted information exchange.

The [Forty-fifth Meeting of the IEC-ISO-ITU-UNECE Electronic Business Memorandum of Understanding Management Group](#) was held from the 12th to the 13th of December 2023.

The meeting, attended by International User Groups with a core mission in electronic business standards, aimed at coordinating work programs. The overarching goal is to optimize the utilization of limited resources for standardization, ensuring efficiency and relevance in the ever-evolving digital landscape. The meeting saw active participation from a diverse group of 39 attendees, both physically and remotely engaged. The meeting focused on facilitating new and advancing existing areas of coordination. New areas of coordination in the domain of e-business were identified: privacy and privacy-by-design, PKI, on geospatial, metaverse, digital health certificate, SMART standards, industry data and artificial intelligence.



Furthermore, the meeting reported on the past [Webinar on Semantics and Semantic Interoperability](#). The report encapsulates the pivotal discussions and insights from the recent global gathering on semantics and semantic interoperability organized by the [IEC-ISO-ITU-UNECE Electronic Business Memorandum of Understanding Management Group](#). In a world inundated with diverse data, this report serves as a compass, guiding readers through the profound considerations, anticipated advantages, and challenges explored by international experts. From the evolution of data exchange structures showcased by the United Nations Centre for Trade Facilitation and Electronic Business to ISO's endeavors in implementing semantics in industrial data and IEC's perspectives on semantic interoperability in smart cities, the report unfolds a rich tapestry of knowledge. Delve into the collective wisdom of these global authorities as they navigate the intricacies of electronic business, offering valuable insights and forging pathways toward harmonization and interoperability in our digital landscape.

The UN/CEFACT's reported progress on several key actions including:

- Publication of updated UN/CCL, UN/LOCODE, UN/EDIFACT Directories and various other technical specifications.
- Achieved the publication of API-related specifications and new active work on developing API construction guidelines.
- Completed Recommendation No. 48 on Private Sector Participation in National Trade Facilitation Bodies.
- Progress on White Papers for Digitizing Transit Accompanying Documents and Digital Product Conformity Certificates Exchange.
- Launched Recommendation No. 49, "Transparency at Scale," addressing traceability in supply chains.



A new version of the UN Trade Facilitation Implementation Guide e-learning platform has been launched and presented in Albania, Azerbaijan and Uzbekistan. More trainings are planned in 2024. This training tool, available in Arabic, English, French, Russian and Spanish, has received over 7 million hits to date, from more than 300,000 single users.



Under the [Sustainability Pledge initiative](#), UNECE supported the implementation of ESG traceability with the blockchain pilots for textiles and leather throughout value chains (check out: Updated Report on the Blockchain Pilots Project for the Garment and Footwear Sector). In 2023, the UNECE's call to action the Sustainability Pledge received +100 pledges from +750 actors globally.

Jointly with the Regional Adviser, the secretariat is advancing on developing the National Trade Facilitation Roadmap for Uzbekistan, scheduled to launch in 2024.

Building on the results of the Survey, a technical assistance project “Enhancing capacity to develop evidence-based policy making for digital and sustainable trade facilitation, to support the accession to the WTO of targeted beneficiary countries in the Central Asian region” is in the process of being implemented, with a focus on Azerbaijan, Uzbekistan and Turkmenistan. Accordingly, a policy study is being prepared under the project and a technical workshop has been organized in Baku, Azerbaijan on 20 November during the 18th Session of the SPECA Working Group on Trade and the 2023 SPECA Economic Forum, in collaboration with ESCAP, with high-level participants from the Republic of Tajikistan, Azerbaijan, the Kyrgyz Republic, Uzbekistan, Turkmenistan, Kazakhstan.



The [2023 Global Report of the Digital and Sustainable Trade Facilitation](#) was launched on 15 September in Geneva during the WTO Public Forum, co-organized by ESCAP, UNECE and UNCTAD, with speakers from the governments of Bosnia and Herzegovina, Pakistan and Republic of Uzbekistan and partner organizations such as UNCITRAL exchanging perspectives and experiences.



Shaping the future of the digital economy



During the [UNCTAD eWeek](#) – Shaping the Future of the Digital Economy on 4th to 8th December 2023, UNECE co-organized two events. The Postal Network as an Enabler for e-Commerce and Trade Facilitation, co-organized with UPU; the session showcased UN/CEFACT's standards in support of the postal industry.



Another side event on the [UN Global Survey on Digital and Sustainable Trade Facilitation](#) has also been organized by UNECE and ESCAP on 6 December 2023 in Geneva during the [UNCTAD eWeek 2023: Shaping the future of the digital economy](#). Speakers from UNECE, ESCAP and UNCTAD, as well as country representatives from the Netherlands, United Kingdom and Kyrgyz Republic have presented latest findings and policy initiatives from the Survey.
