Relation with ISO TC154 ISO TC154 CAT letter to UNECE Director Chinese project proposal MOU MG Project General relationship between UN/CEFACT and ISO/TC154 	It was discussed that ISO TC154 may initiate work that may overlap with UN/CEFACT work (work in the Supply Chain Domain and Recommendation for ensuring legally significant trusted trans-boundary electronic interaction). The MoU/MG Annexes are currently being revised. The rationale is to update the list of participating organizations without modifying the MoU itself. There is a need to strengthen the general relationship between UN/CEFACT and ISO TC154. Some ideas are: • Re-establishment of formal relations (e.g. exchange of liaison officers); • Representation of UN/CEFACT at key meetings such as the Plenary; • Encouraging participation of UN/CEFACT experts in ISO TC154 work, including through planning back-to-back meetings; and • Improve the functioning of joint groups.	The Bureau will reach out to relevant UN/CEFACT Domain Coordinators and experts. Liaison matters to be discussed with ISO TC154 in the coming months
5c. Relation with ISO TC204	An e-mail was received from ISO TC204 indicating that they may initiate work that could overlap with work in the UN/CEFACT Agriculture Domain and Transport and Logistics Domain. It is the Bureau's understanding that there is no formal work item proposal in TC204 at this time, so no action is required. The Bureau agreed to put the relevant UN/CEFACT and TC204 experts in contact to avoid overlap and ensure coherence between ongoing and forthcoming work in this area.
