- Our members are **procurement experts** from EU public and private sectors which contribute to define common requirements






## **Bll guides implementation of standards**

- The focus of BII is on collecting European requirements and to **provide guidance for consistent implementation** of existing international standards.



## **Our Approach to Interoperability**

**Syntax** 



## A **Profile** is a technical specification describing:

- the choreography of the business process(es) covered,
- the electronic business transactions exchanged as part of the business process,
- the **business rules** governing the execution of that business process(es), its business collaborations and business transactions, as well as any constraints on information elements used
- the **information content** of the electronic business transactions exchanged, documented in the form of transaction Information Requirement Models based on a common vocabulary of business terms.







## **Core information requirements**



- BII is defining **core** information requirement models
  - the set of information elements sufficient to cater for the generally expressed business requirements applicable throughout the European market.
- BII specifications can be implemented as is, but may also be further customized for community use.





# Bll deliverables are based om European requirements in public procurement





- The third phase of the BII initiative focused on capturing new (and refining the existing) business requirements.
  - In the pre-award area the EU directive for public procurement 2014 provided many new requirements.
    - With the new directive 15 standards forms for notification were updated and 6 new forms were introduced.
    - The directive also introduced a complete new concept for self-declaration, that is the European Single Procurement Document.
  - Another source for new requirements was the eSENS project, a new EU Large Scale Project.
    - The eTendering pilot in eSENS has the main objective to proof the system-to-system concept advised by the eTendering expert group (eTEG) in 2012.
    - BII3 catered for eSENS by providing 10 new profiles and at least 15 new transactions. A lot of these new profiles were inspired by the XVergabe standards.




## Gaps in UN/CEFACT syntax binding



- During the third phase of the workshop attempts to create a syntax bindings were not successful. Comparing the Information Requirements Models in the BII3 profiles to the UN/CEFACT D11A syntax resulted in major gaps. Even to the point that the syntax is hardly implementable anymore.
- Therefore the workshop decided <u>not</u> to create syntax bindings for the BII3 pre-award deliverables to the currently known UN/CEFACT standard for notification and tendering.
