- Pink classes are new classes


#### **Data Types**

ISO uses mostly data type 'text' for identifications. UN/CEFACT uses 'Identifier'. This is the reason for differences on data-type.


#### **Qualified Data Types (code lists and values)**


## Pay Master Message Structure




# POF Request Message Structure
