Summary of the conference call

Following the suggestions from the conference call announcement, we addressed the following points (line references refer to draft version 0.7):

- Lines 177-190, these examples (of levels of functions of signature) should be reworked as their logic may reinterpret the rest of the document.
 - These examples were removed from the text
- Lines 192-211 (on authenticity). I propose that this definition be completely deleted from the text. It is not used elsewhere and it is leading to reinterpretations of the term authentication / to authenticate.
 - This definition has been completely removed.
 - It seems necessary to have some sort of common understanding as to what is meant by the term "authentication". Any suggestions before the Geneva Forum (before April 10th) would be welcome.
- Lines 219-233 (on the parties considered in the transaction) is not being used elsewhere. This entire section was an attempt to re-state the section on documents present in the 1979 version in a more neutral and encompassing method. But if this part of the section is not pertinent, it may be better to delete it in the next version.
 - The pertinence of this section is not clear, though mentioning the role of the actors seems to be a good idea. This section (3a) needs to be reworked. Any suggestions before the Geneva Forum (before April 10th) would be welcome.
- Lines 285-298 on levels of reliability we need to agree on a term and the principle as it is being used heavily in all of the sections that are being used afterwards.
 - There seemed to be a consensus for the term "Levels of reliability". It was requested
 that the title be further extended to read "Levels of reliability that a document is
 authentic"
 - It seems that we are all on the same track, but there may perhaps still be some varying understandings of what is intended here so we may want to discuss this again at the Geneva Forum.
- Lines 348-363 on third party service providers is a new addition based on some comments that were received.
 - o Some minor adjustments were made and the section was approved.
- Lines 389-394 on confirmation of receipt messages.
 - These confirmation receipts are already explicitly mentioned in the last paragraph of 5b. If there is need for further details, please send these before the Geneva Forum (before April 10th).
- It has come to my attention that the term "confidence" is preferred to the term "trust" as the latter may have technical implications. I suggest we study such a change in lines 156, 157, 236, 372, 597)
 - Few comments were received on this point. The term "trust" was opted to remain in the text.
