# **eManifest Pilot Project**

# Background – long outstanding issue

- 2009 Communication and action plan with a view to establishing a European maritime transport space without barriers'
- 2010 Blue Belt concept discussed at Informal Transport Ministers meeting
- 2010 Reporting Formalities Directive - included FAL Form 2 (Cargo Declaration)
- 2011 Blue Belt pilot project by EMSA
- 2012 Single Market Act II - Together for new growth. Key action 2 - establish a true single market for maritime transport by no longer subjecting EU goods transported between EU seaports to administrative and customs formalities that apply to goods arriving from overseas ports
- 2013 Communication on Blue Belt, a Single Transport Area for Shipping
- 2014 Simplification of RSS procedure
- 2014/2015 Discussions on Proof of Union Status system



# Blue Belt Pilot Project outcome

Voyage information provided to customs - routes, ports of call, expected time of arrival and vessel behaviour - was useful.

Despite the benefits of the project, customs authorities pointed out that it is important to:

- ✓ Include information regarding the goods carried (for cargo tracking), including their status (Union versus non-Union);
- ✓ Extend the service to all vessels, including vessels calling in non-EU ports, and
- ✓ Change Customs legislation to facilitate cargo clearance procedures for intra-EU cargo.

8 Member States are still receiving Blue Belt services

# Objectives of eManifest Pilot Project - A comprehensive eManifest

- a) A harmonised full eManifest encompassing cargo formalities required by both maritime and customs authorities
- b) Reduce the administrative burden of the shipping industry by applying the reporting once principle
- c) Test processes which will increase the efficiency of the maritime transport
- d) Enhance the NSW prototype to allow for the submission of the eManifest together with the other reporting formalities

# Objectives of eManifest Pilot Project - Exchange of eManifest

- a) Allow Member State authorities to receive cargo information on departure from last EU port
- b) Assess whether the exchange of eManifest can minimise the reporting obligations for ships trading between EU ports, as well as when the voyage includes non-EU ports
- c) Assess the tracking of cargo carried onboard ships, including portraying it on a graphical interface

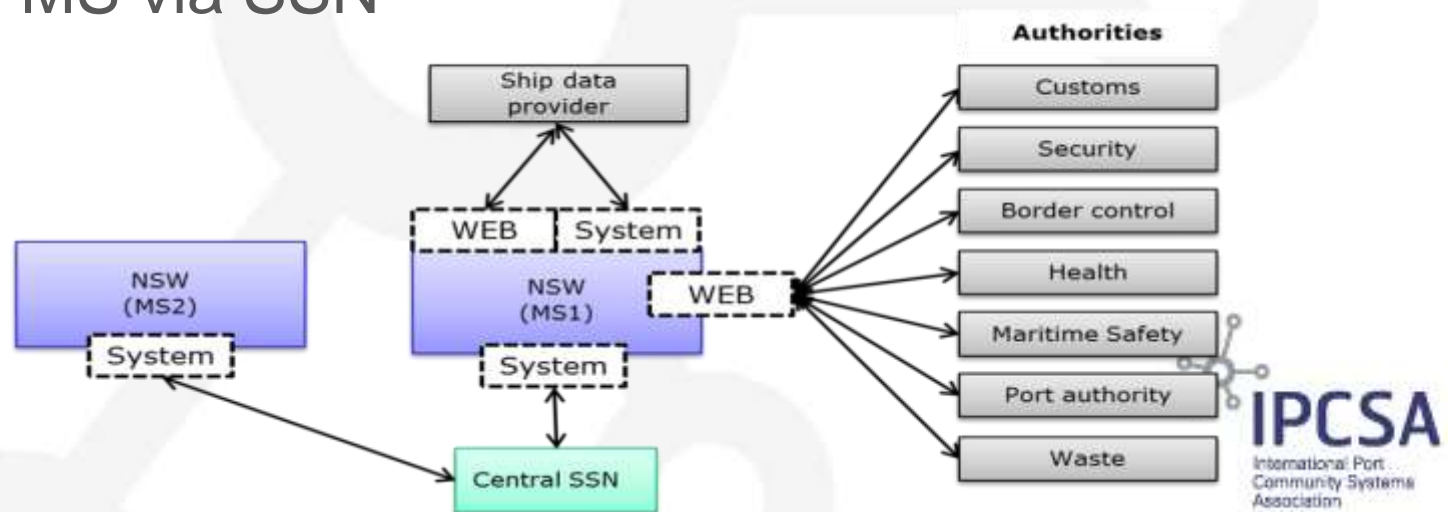


# Draft Business Rules

1. Scope of eManifest – cargo formalities and processes to be included in the scope of project
2. Submission of eManifest – who, how, when, what, validation of data
3. Link with authorities – distribution of data, communication of decisions
4. SafeSeaNet - exchange of eManifest
5. Content of the eManifest – cargo sent with other data, use of international message standards

# Use of Enhanced NSW prototype

1. Arrival eManifest is submitted to the NSW with other reporting formalities
2. Data is distributed to relevant authorities
3. Authorities report decisions
4. Departure eManifest can be shared with authorities in other MS via SSN

Evaluation – conclusions and recommendations	January/February 2017

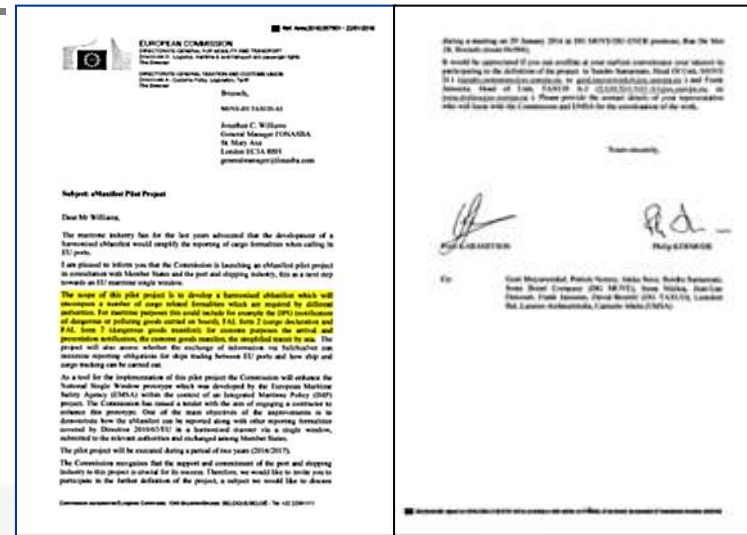
