UN/CEFACT Report to HoD – June 2015

RECENT DEVELOPMENTS

Geneva 25th Forum April 20 to 24 2015 – Project development

The Forum was overall acclaimed as very fruitful. It was attended by more than 130 experts from over 30 countries from around the world, with participants coming from the private sector, public-sector administrations, non-governmental organizations, and universities. The Bureau held open meetings where each domain and project provided updates. Some of the progressions on projects during the week included:

- International Trade Procedures Domain finalized two draft recommendations and decided to launch a revision of Recommendation 1 (UN Layout Key), pending internal consultation;
- Single Window Domain finalized a draft for G2G Single Window Interoperability and launched an internal review of the text;
- Finance & Payment Domain continued its work on the "Purchase Orders" and "Trade Finance into TF" projects, while launching a revision of the "Cross Industry Remittance Advice" project;
- Transport & Logistic Domain advanced its work on the Multi-Modal Transport project and is preparing a new project on an e-BOD (Bill of Delivery) for Logistics
- Accounting & Audit Domain progressed its work on the e-Journal project and closely studied the work which is being proposed within ISO on Audit
- E-Government Domain continued its work on the Trusted Transboundary project
- Agriculture Domain continued its work on its four active projects (Animal traceability data exchange, Rapid alert system for food and feed, e-Laboratory observation report, Fisheries catch data) and launched a proposal for a new project on eCrops

Geneva 25th Forum April 20 to 24 2015 – Other developments

Several key topics were discussed during the Forum week. The first was within the Bureau and with all of the Domain Coordinators in order to finalize a Terms of Reference for 'Domains' and 'Domain Coordinators.' This was completed and approved by the Bureau.

Another major topic was addressed, the core component technical specification (CCTS). For the past several years, UN/CEFACT has listed two separate CCTS on its website. The Methodology and Technology group organized an open meeting during the Forum in order to decide on a way forward in order to clarify this situation and eventually promote one single specification. The discussions hosted key members from all of the Programme Development Areas and a consensus of the experts was reached. The discussions are now being taken up in the Bureau to finalize a position. This will be announced in the weeks ahead.

There was a parallel event on UNLOCODEs on the Friday 24th. This was well attended and proposed some very informative presentations. Two initial outcomes from this event include the establishment of UNLOCODE contact points nationally and a proposed terms of reference for this and secondly, a proposition to revise Recommendation 16 on this topic.

Domains

A terms of reference for domains was finalized during the 25th Forum. The next step will now be to select/confirm the leadership for each of these domains. Compliant to the Terms of Reference (TORs), an announcement will be published to allow all suitable candidates to put forward their candidatures during the month of June.
