RECENT DEVELOPMENTS

Ratification of the WTO-TFA

On 22 February 2017, the WTO Trade Facilitation Agreement (TFA) was officially ratified. https://www2.unece.org/cefact/display/themepressdemo/WTO+Trade+Facilitation+Agreement

As per its "Perspective Directions" strategy document, UN/CEFACT remains dedicated to deliver standards and guidance material which will help countries to comply with their TFA obligations. Many deliverables and standards exist already, such as Rec1 (UN Layout Key), Rec4 (National Trade Facilitation Bodies), Rec18 (Facilitation Measures), Rec33, Rec34, Rec35, Rec36 (on different aspects of Single Window), Rec40 (Consultation Approaches), as well as our technical and e-Business deliverables such as the UN/Core Component Library, UN/EDIFACT, UN/LOCODE, UN/TDED, Code Lists, BRSs and individual eBusiness standards.

Reminder that the Trade Facilitation Implementation Guide website (TFIG) provides a mapping of deliverables from UN/CEFACT and other organizations to each article of the WTO-TFA. This website also provides a itineraries, domains and instruments to help countries and businesses to implement trade facilitation measures and eBusiness standards. http://tfig.unece.org/
