1b. Domain pages for UN/CEFACT public website

4a. Preparations for the Bangkok Forum

5a. Preparation for the MoU/MG meeting 1-2 June

Preparation of the excel spreadsheet on signatories' activities

The background and purpose of collecting feedback from the Domain Coordinators was explained.

It was noted that it is difficult to understand some of the headings/topics used in the Excel spreadsheet, as they could be interpreted in different ways. Some topics that were not in the list were added (insurance, financial services, accounting, etc.).

The secretariat explained the difference between "signatories" and "participatory user groups", and noted that there is currently a discussion in the group on whether the latter should sign the MoU (as user groups, not signatories).

It was reported that it appears that the work of ISO PC295 will create a lot of duplication with the work of UN/CEFACT. The official liaison (Eric Cohen) will report to the secretariat so that it can be brought up at the MoU/MG meeting.

Possible duplication in the area of transport/logistics and agriculture will also be reported to the secretariat. Transport and Logistics Domain would like to nominate an official representative for ISO TC204; a request will be sent to the Bureau via the PDA Vice Chair.

Run through of the agenda

Item 6.3 (R15/05)

The purpose of this work is not to create a new semantic standard, but rather to see if software can be developed that would be able to bridge existing libraries and define terms in different languages. For this, there is a need for knowledge as well as finance for software development.

In principle, UN/CEFACT should be taking the lead; this is in line with the "semantic hub" notion in the UN/CEFACT Prospective Directions. The work done in UN/CEFACT on publication formats is foundational. However, we need to see if we have the technical capacity for this.
