The Multi-stakeholder forum on private sector involvement in national trade facilitation bodies that I propose to you is based on the following considerations, which are only my mini proposal to start the discussion with all of you.

Introduction and purpose

In large-scale standardisation development projects, it is good practice to set up a multi-stakeholder forum which, in this case, will encourage the widespread involvement of the private sector in national standardisation and trade facilitation bodies.

The aim is to have a multi-stakeholder forum participated by institutional bodies, public administrations and the private sector through

- the widest representation of all stakeholders involved,
- the observation of international trade services provided by public or private entities in order to prove their usefulness and scalability towards the private sector,
- the detection of criticalities in order to propose improvements,
- research activities in relation to the rights of the stakeholders involved.

The above-mentioned practice is by now consolidated and is also permanently used in the EU Member States, as happened in Great Britain with the Open Identity Exchange of the British identification regime called "Gov.UK Verify", which has a multistakeholder forum that supports the adoption and speeds up the implementation phase, with considerable benefits in terms of time and economic savings. International trade involves, and will increasingly involve, a very large number of citizens, businesses, administrations (central PAs, regions, municipalities, provinces), private economic entities (banks and payment service providers, services) and professionals and, because of its impact on the economy, the efficiency of the country's economic sector... it represents a fundamental strategic piece in the national context that has standardisation as one of its important elements.

In this context, the launch of a multi-stakeholder forum that aims to develop its activity starting from the involvement of all stakeholders also in national standardisation

activities and national and international strategies to boost trade with particular reference to SMEs.

The multi-stakeholder forum, formed by different representations of public and private legal persons, as well as business associations, bodies and citizens' associations can be an element of acceleration in the process of involvement of the national economic system towards the world of standardization through a constructive, fair, open and concrete comparison that can help UNI (NSB of Italy) to quickly reach the objectives expected by everybody.

Objectives and fields

The activities that we propose to start within the multi-stakeholder forum are the following:

- Dissemination of all the already standardised tools, of its objectives and of the
 available tools for digital data interoperability, promoting the adoption of new
 standards and tools in order to increase the confidence towards the world of
 standards especially for SMEs;
- Analysis of the criticalities encountered;
- Analysis of critical issues in the field of privacy and security;
- Analysis of critical issues related to civil law;
- Analysis of critical issues related to the technical functionality of the sites and classification of dysfunctions;
- Participation in the drafting and validation of interoperability tests;
- Analysis of the criticalities reported in relation to the control and supervision phases.

Modalities and method

The working group, in the first start-up phase, shall be formed trying to have the maximum representation of potential stakeholders.

At present, the subjects to be contacted will be known directly by the promoters. It is envisaged that it will be integrated on the basis of criteria that strengthen the representativeness of interest groups that are significant in terms of size (of the subjects they represent) and that have a widespread territorial location, in collaboration with the reference authority.

The purpose of this multi-stakeholder forum is concrete, constructive and aimed at providing serious and scientific, evidence-based monitoring, providing data and consultative scenarios, without any binding power.

Deliverables

Four areas are to be monitored on a quarterly basis and reports are to be provided to the participants of the multi-stakeholder forum only, to be disseminated to their members if necessary:

- Legal analysis report
- Technical analysis report

- Functional-organisational analysis report
- Report of sociological-communication analysis

I look forward to receiving your comments and critics in order to improve this idea, and I hope that you will support it.


